NOTIFICATION

Pursuant to the decision of the Core Committee for the Admission Process and with approval of competent authority, the following directions are hereby issued for UG 3rd and 5th semester admissions:

1. The admission process for UG 3rd and 5th semester students seeking renewal in the same college shall be carried out by the concerned colleges themselves and completed within 31st August, 2025. The Samarth enrolment number (for both 3rd and 5th semester) must be used to ensure data uniqueness.
2. After completion of the process, necessary student data, including fee waiver details as applicable, must be uploaded in the Samarth portal.
3. Admissions under the Fee Waiver scheme for both 3rd and 5th semesters are completely free. No fees of any kind are to be collected under this scheme. (Private institutions and Venture colleges are excluded from Fee waiver scheme)
4. The admission fee for 3rd / 5th semesters shall remain the same as that charged earlier for 3rd/5th Semesters and will continue unchanged throughout the duration of the course. (Does not apply to Private/Venture HEIs)
5. Upon completion of admissions, all student data including hostel admissions and applicable fee waiver information must be updated in the Samarth portal by the concerned institutions.

This notification is issued for strict compliance by all participating colleges and universities and shall come into effect immediately.
